



## CLUB Adventure Awaits Sweepstakes

### Sweepstakes Official Rules

NO PURCHASE OR OBLIGATION NECESSARY TO ENTER OR TO WIN. YOU HAVE NOT WON YET! A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

**1. Sweepstakes Period:** The **CLUB Adventure Awaits Sweepstakes** (the "**Sweepstakes**") will begin Tuesday, September 1, 2020 at 12:01 a.m. Central Time ("**CT**") and end at 11:59 p.m. CT on Saturday, October 31, 2020 (the "**Sweepstakes Period**"). The Sweepstakes will consist of one (1) drawing ("**Drawing**") to award three (3) prizes (each a "**Prize**"). The random Drawing will be conducted on or about Thursday, November 12, 2020 by the Administrator from all eligible entries received during the Sweepstakes Period. The designated clock maintained by the Sponsor in connection with the operation of the Sweepstakes at [www.basspro.com](http://www.basspro.com) (the "**Website**") will be the official timekeeper of this Sweepstakes.

**2. Sponsor/Administrator.** The Sweepstakes is sponsored by Bass Pro Group LLC., 2500 E Kearney, Springfield Missouri, 65898 ("**Sponsor**"), and administrated by Cohen-Friedberg Associates, LLC, 17 Lantern Road, Suite 1, Framingham, MA 01702 [www.cfapromo.com](http://www.cfapromo.com) ("**Administrator**").

**3. or the contact information listed on the Alternate Means of Entry postcard. Sponsor shall have no liability for any potential prize winner notification that is lost, intercepted or not received by any potential prize winner for any reason. If, despite reasonable efforts, any potential prize winner does not respond within four (4) business days of the first notification attempt, or if the prize notification is returned as unclaimed or undeliverable to such potential prize winner, such potential prize winner will forfeit his or her prize and an alternate winner may be selected by random drawing.
