

**BASS PRO SHOPS/CABELA'S  
2018 FALL HUNTING CLASSIC SWEEPSTAKES  
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia ("U.S.") and Canada (excluding Quebec) who are 21 years of age or older at time of entry. Employees of Bass Pro Intellectual Property, L.L.C., a Missouri Limited Liability Company; Bass Pro Shops Canada (Calgary), Inc., a Canadian corporation; Bass Pro Shops Canada, Inc., an Ontario corporation (the "Sponsors"), Cabela's LLC ("Cabela's"), and their respective subsidiaries, agencies, affiliates and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household of such individuals are not eligible. 2. **SWEEPSTAKES PERIOD:** The 2018 Fall Hunting Classic Sweepstakes ("Sweepstakes") begins at 12:00 am Central Time ("CT") on August 10, 2018 and ends at 11:59 pm CT on August 26, 2018 ("Sweepstakes Period").
3. **TO ENTER:** You may enter two ways:

In-Store:

Entry forms are available at participating Bass Pro Shops and Cabela's locations. To enter, complete an official entry form (or hand print your name, complete address, daytime phone number, email address and date of birth on a 3"x5" piece of paper) and deposit your entry in an official ballot box at one of the participating Bass Pro Shops and Cabela's locations during the Sweepstakes Period. Entries must be received by close of business on August 26, 2018.

Online:

You may also enter by visiting [www.basspro.com/huntingclassic](http://www.basspro.com/huntingclassic) or [www.cabelas.com/huntingclassic](http://www.cabelas.com/huntingclassic) ("Web Site") during the Sweepstakes Period. Complete the entry form and submit as directed. Entries must be received by Web Site's server by 11:59 pm CT on August 26, 2018. Web Site's server is the official clock for this Sweepstakes.

4. **DRAWING/PRIZE/ODDS:** On or about August 27, 2018, a random drawing will be conducted by Promotion Mechanics, Inc. ("PMI"), an independent judging organization, to select one participating store (online entries will be grouped together to represent one "online store"). The store that is selected in the drawing will then conduct a random drawing to select one winner from among all eligible entries received at that particular store (if the "online store" is selected, then PMI will conduct a random drawing from among all eligible online entries received). The following prize will be awarded:

(1) Grand Prize: a two-passenger 2017 Textron STAMPEDE UTV valued at approximately \$14,599, and, a trip for winner and one guest to attend the Bank of America 400 at Charlotte Motor Speedway (trip must be taken Thursday, September 27 – Monday, October 1, 2018).

The trip portion of the prize consists of round trip coach air transportation from the major commercial airport closest to winner's residence; use of a rental car (winner and/or winner's guest must be eligible and comply with rental company's terms and conditions or this portion of the prize will be forfeited); standard double-occupancy hotel accommodations for 4 nights; 2 tickets to the Bank Of America 400 at Charlotte Motor Speedway; the opportunity to meet Daytona 500 Champion Austin Dillon; a \$500 Bass Pro Shops or Cabela's gift card; and \$500 spending money.

Total combined approximate retail value of the Grand Prize is \$18,048. Actual value will be determined by winner's residence and seasonal rates. Any difference between the actual value and the stated value will not be awarded. Winner and guest must possess all required, valid travel authorizations in order to travel.
