

**BASS PRO SHOPS/CABELA'S  
2018 "GONE FISHING" SWEEPSTAKES  
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia ("U.S.") and Canada (excluding Quebec) who are 21 years of age or older at time of entry. Employees of Bass Pro Intellectual Property, L.L.C., a Missouri Limited Liability Company; Bass Pro Shops Canada (Calgary), Inc., a Canadian corporation; Bass Pro Shops Canada, Inc., an Ontario corporation (the "Sponsors"), Cabela's LLC ("Cabela's"); Toyota Motor Sales, U.S.A., Inc. To enter, complete an official entry form (or hand print your name, complete address, daytime phone number, email address and date of birth on a 3"x5" piece of paper) and deposit your entry in an official ballot box at one of the participating Bass Pro Shops and Cabela's locations during the Promotion Period. Entries must be received by June 21, 2018.

Complete the entry form and submit as directed. Entries must be received by Web Site's server by 11:59 pm CT on June 21, 2018. Web Site's server is the official clock for this promotion.

- 4. U.S. DRAWING/PRIZE/ODDS:** On or about August 3, 2018, a random drawing will be conducted by Promotion Mechanics, Inc. ("PMI"), an independent judging organization, from among all eligible U.S. in-store and U.S. online entries combined to award the following prize to one winner ("U.S. Winner"):
