

**BASS PRO SHOPS AND CABELA'S
2019 FALL HUNTING CLASSIC SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR CLAIM PRIZE.
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia ("U.S.") and Canada (excluding Quebec) who are 21 years of age or older at time of entry. Employees of Bass Pro Outdoor World, L.L.C.; Bass Pro Shops Canada (Calgary), Inc., a Canadian corporation; Bass Pro Shops Canada, Inc., an Ontario corporation (the "Sponsors"), Cabela's Wholesale, L.L.C. ("Cabela's"), and their respective subsidiaries, agencies, affiliates and members of the immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household of such individuals are not eligible. Void in Quebec and where prohibited.
2. **SWEEPSTAKES PERIOD:** The 2019 Fall Hunting Classic Sweepstakes ("Sweepstakes") begins at 12:00 am Central Time ("CT") on August 9, 2019 and ends at 11:59 pm CT on August 25, 2019 ("Sweepstakes Period").
3. **TO ENTER:** You may enter two ways:

In-Store:

Entry forms are available at participating Bass Pro Shops and Cabela's locations. To enter, complete an official entry form (or hand print your name, complete address, daytime phone number, email address and date of birth on a 3"x5" piece of paper) and deposit your entry in an official ballot box at one of the participating Bass Pro Shops or Cabela's locations during the Sweepstakes Period. Entries must be received by close of business on August 25, 2019.

Online:

You may also enter by visiting www.basspro.com/huntingclassic or www.cabelas.com/huntingclassic ("Web Site") during the Sweepstakes Period. Complete the entry form and submit as directed. Entries must be received by Web Site's server by 11:59 pm CT on August 25, 2019. Web Site's server is the official clock for this Sweepstakes.

LIMIT ONE ENTRY PER PERSON, REGARDLESS OF METHOD OF ENTRY. No mechanical reproductions permitted.

4. **DRAWING/PRIZE/ODDS:** On or about October 15, 2019 a random drawing will be conducted by Promotion Mechanics, Inc. ("PMI"), an independent judging organization, from among all eligible entries received to award the following prize:

(1) **Grand Prize:** a Fall Hunting Classic Prize Package consisting of a 3-Day Turkey Hunt for winner (no guest) at Salt River Outfitters in Kentucky, US; a Tracker OX 400 ATV; and, if winner is a U.S. resident, a Winchester shotgun and ammunition.

The trip portion of the prize consists of US\$2,000 (to be awarded as a check made out to the winner) intended to be used for air travel and car rental expenses; standard accommodations at Salt River Outfitters for 4 nights; selected meals; a tour of a nearby bourbon distillery selected by Sponsors; one pair of Oakley sunglasses (specific style and color to be determined by Sponsor); and a required hunting license for the trip (winner must qualify/be eligible for such license; if winner is ineligible to receive the required license, the prize will be forfeited). **Winner must provide his/her own firearm for the hunt. Winner must take prize trip on dates specified by Sponsors, anticipated to be April 21-26, 2020, and as otherwise stated in these Official Rules.** Total combined approximate retail value ("ARV") of the trip portion of the prize is US\$4,000. Actual value will be determined by winner's residence and seasonal rates. Any difference between the actual value and the stated value will not be awarded.

Also included in the prize is a Tracker OX 400 ATV, ARV US\$5,799. The depiction of the prize in any advertising, promotional materials, or displays may not reflect the actual prize winner will have to retrieve. Sponsor will determine all features of prize including, but not limited to, color of exterior and interior. In addition, if the winner is a U.S. resident, the prize will also include a Winchester SXP Turkey Hunter shotgun, ARV US\$519.99, and (3) boxes of Winchester ammunition, ARV US\$71.97. Winner must meet all federal, state and local regulations and requirements pertaining to obtaining, possessing and using a firearm prior to receiving prize. If winner does not meet all regulations and requirements to receive such prize, the prize will be forfeited in its entirety and an alternate winner will be selected. **If winner is a Canada resident, the Winchester shotgun and ammunition portion of the prize will not be awarded, and no substitution or compensation will be offered.**

The total combined ARV of Grand Prize if winner is a U.S. resident is US\$10,390.96. The total combined ARV of Grand Prize if winner is a Canada resident is US\$9,799.
